When you submit an enquiry via our website

When you submit an enquiry via our website, we ask you for your name, contact telephone number and email address.

We use this information to respond to your query, including providing you with any requested information about our products and services. We may also email you several times after your enquiry to follow up on your interest and ensure that we have answered it to your satisfaction. We will do this based on our legitimate interest in providing accurate information prior to a sale.

Your enquiry is stored and processed by our operations manager, the information is only retained in the event of a legitimate trade interest or question that requires further consultation. All information is erased in the event of other enquiries that have been resolved or enquiries that have not resulted in a sale or business interest.

We do not use the information you provide to make any automated decisions that might affect you.

We keep enquiry emails for two years where a legitimate interest is shown, after which they are securely archived and kept for seven years, when we delete them. CRM records are kept for three years after the last contact with you.

Other types of transactions via our website

Any document on our website or apps are provided freely with no retention of personal details aside from previously mentioned cookies.

Your rights as a data subject

By law, you can ask us what information we hold about you, and you can ask us to correct it if it is inaccurate. If we have asked for your consent to process your personal data, you may withdraw that consent at any time.















If we are processing your personal data for reasons of consent or to fulfil a contract, you can ask us to give you a copy of the information in a machine-readable format so that you can transfer it to another provider.

If we are processing your personal data for reasons of consent or legitimate interest, you can request that vour data be erased.

You have the right to ask us to stop using your information for a period if you believe we are not doing so lawfully.

Finally, in some circumstances you can ask us not to reach decisions affecting you using automated processing or profiling.
