

# Privacy Policy for AI Chatbots

## 1. Introduction

Welcome to Waste Mission's AI Chatbot Privacy Policy. We value your privacy and are committed to protecting your personal data, with full transparency. This policy outlines how we collect, use, and safeguard your information. By using our AI chatbot, you agree to follow guidance in **3. User Responsibilities**, and all other terms outlined here.

## 2. Information We Collect

- We keep a record of chat logs for all conversations with our AI chatbot indefinitely. This includes all text entered by the user, all chatbot responses and appropriate timestamps.
- We collect IP addresses for all chatbot users.
- We collect feedback in the form of a 'thumbs-up' or 'thumbs-down' for AI-generated responses.
- We DO NOT anticipate identifiable (personal) information be entered into our AI chatbot.

## 3. User Responsibilities

- It is the users responsibility to ensure personal, identifiable data is not entered into the chatbot.
- The user must keep up-to-date with privacy policy changes; more below.
- The user must ensure their questions are legitimate, appropriate and legal.
- The user understands that our chatbots may get things wrong, and agrees it is their responsibility to confirm any information received from them is accurate. ## 4. How We Use Your Information

- To provide and improve our chatbot service, in-part by amending erroneous messages.
- To use analytics for chatbot usage, including the country users accessed from.
